1. Account Maintenance Fees

1.1 Nations Saver – Statement Savings Account

- Minimum monthly average balance – Rs.1,000
- A fee of Rs.50 per month will be levied if the average balance is below Rs.1, 000.

• Nations Saver – Passbook Savings Account

- Passbook replacement fee – Rs.500

1.2 Nations Salary Saver

- Salary Saver Individual client transfers less than Rs.10,000 per month – Rs.250
- Salary Inner Circle - Salary transfer less than Rs.75,000 per month – Rs.1,000
- Salary Inner Circle - Salary transfer less than Rs.100,000 per month – Rs.1,000 (For accounts opened after 1st June 2020)

- Rs.1, 000 will be held in the account

- Stop Payment Cancellation - Per item Rs.500
- If the cheque amount is not stated on the stop payment letter and funds not available Rs.4,000/-
- Cheque return notification Postage (*Per CRN) Rs.50 (If not collected from branch and posted only)

*If multiple CRNs simultaneously there will be one postage charge
