

Late Payment Fee & Minimum Payment Calculation method

- The late payment fee is charged if the minimum payment is not settled before the due date.
 - The minimum payment is the amount specified on the Statement as the minimum amount payable by the Payment Due Date. The minimum payment will be at least LKR 250.
 - If the minimum payment is not settled, the unpaid minimum payment amount will be added to the minimum payment due for the following month.
- The fee is charged is a one-time flat fee per billing cycle in addition to any interest applicable on unsettled balances.
- The late payment fee amount is LKR 2,000.
- This fee is levied in the following instances:
